The World Health Organisation Framework Convention on Tobacco Control (WHO FCTC) Article 5.3 is geared towards safeguarding public health policy-making from tobacco industry interference. The accompanying guidelines stipulate that all decision-makers "should interact with the tobacco industry only when and to the extent strictly necessary to enable them to effectively regulate the tobacco industry and tobacco products." The guidelines state that "where interactions with the tobacco industry are necessary, Parties should ensure that such interactions are conducted transparently". Will you, as commissioner, implement an immediate ban on all Commission contacts with the tobacco industry unless there are exceptional circumstances, in line with article 5.3?

The European Food Safety Authority is a crucial institution to protect public health, however its independence policy has been repeatedly shown to not be up to the job. An October 2013 investigation ("Unhappy Meal", by Corporate Europe Observatory and Stéphane Horel) found that nearly 59 per cent of scientists on the agency's panels had direct or indirect ties to commercial companies falling under the agency's remit. The European Parliament voted in plenary last April a resolution demanding the agency to ban scientists with conflicts of interest with industry, by imposing "a two-year cooling-off period to all material interests related to the commercial agrifood sector", a simple, effective measure which would solve the problem. However, EFSA's new independence policy (from last July 31st) simply ignores this demand. The former commissioner in charge of food safety always denied the problem. Will you ask EFSA to at last strengthen its independence policy for good and stop ruining the EU's reputation?

Until recently you owned shares in two petroleum-related companies, Petrolífera Dúcar and Petrologis Canaris. Two of your family members hold important positions in the same two companies, and members of your family continue to hold a significant part of the shares in both companies:

You announced that you have sold your shares in the petroleum companies. Did you sell them on the stock market or to individual persons, and if the latter, to whom did you sell the shares?

Please explain your personal connection to Havorad BV, the company that is the largest shareholder in Petrolifera Dúcar and Petrologis Canaris and which was the largest shareholder when you acted as chairman of the two companies. Are you, or have you been in the past a beneficial owner, director, administrator, partner or shareholder of Havorad BV? How exactly were you related to Havorad BV in the past and how are you currently related to it? What exactly are your family (including in-laws) connections to Havorad BV?

Spanish public prosecutors have stated that Havorad BV is a shell company. You refused to answer questions about your involvement in companies that use tax havens and secrecy jurisdictions during the election campaign for the European Parliament. You said that you that you would consider answering those questions about after the elections, but haven't made any public statements since. Have you held shares or an official position in a company that is registered in a secrecy jurisdiction, such the Dutch Antilles, Panama or Costa Rica? Can you clarify your links to the company Angelmo International, which has been linked to a tax fraud scheme? Is it correct that you partly represented the Angelmo International in Spain during the time the tax avoidance scheme was carried out?

How is it credible that you can take decisions on Europe's energy and climate policy without a conflict of interest when your family is invested in two energy-related companies? How will you ensure that no conflicts of interest arise when you deal with decisions affecting the oil sector?

How will you deal with lobbyists that represent the oil sector given your own past in, and your current family ties to, the sector? What concrete steps will you take to ensure that your public mandate and private interests do not conflict?

A company registered in your wife's name, Agricola Micaela Domecq SL, is a recipient of significant payments from the EU's Common Agricultural Policy (CAP). So are several other companies, which are owned by close relatives of yours. How will you deal with decisions in the college of commissioners that affect the CAP and other decisions that could financially affect the agricultural interest of your family? Will you recuse yourself from decisions that could affect the CAP?

Given your repeated failings in the past to fully declare your and your family's financial interests, what additional steps will you take to fully disclose all financial interests, including your family's?

There is much public concern about the lack of commission transparency regarding the ongoing TTIP negotiations. Do you agree that citizens have the right to know what is being put on the table on their behalf and how this is being negotiated? As commissioner for trade will you ensure that the negotiating mandate, all documents submitted by the EU during the negotiations, and the negotiating texts themselves are immediately published online?

Recently the European Ombudsman has urged the European Commission and the Council to "to step up their proactive transparency policy" for the TTIP negotiations following a call from more than 250 civil society organisations on the issue. Will you follow the European Ombudsman's recommendations for more openness and transparency in the EU-US trade negotiations and if so, which concrete steps are you going to take in this regard? Will you ensure that lists of meetings between DG Trade officials and lobbyists will be published online?

Research by civil society groups have revealed a serious imbalance in the Commission's

consultations with stakeholders in the preparations for the TTIP negotiations, with more than 90 per cent of the meetings being with industry whereas trade unions and environmental NGOs were hardly consulted in the crucial phase before the negotiations were launched. This undoubtedly negatively influenced the EU's negotiating positions for the TTIP talks. What will you do to ensure a far more balanced consultation process?

The World Health Organisation Framework Convention on Tobacco Control (WHO FCTC) Article 5.3 is geared towards safeguarding public health policy-making from tobacco industry interference. The accompanying guidelines stipulate that all decision-makers "should interact with the tobacco industry only when and to the extent strictly necessary to enable them to effectively regulate the tobacco industry and tobacco products." The guidelines state that "where interactions with the tobacco industry are necessary, Parties should ensure that such interactions are conducted transparently". Will you, as commissioner, implement an immediate ban on all Commission contacts with the tobacco industry unless there are exceptional circumstances, in line with article 5.3?
